Graham is currently Lead Optometrist at the University of Melbourne Glaucoma Clinic. He established his private practice in 1991 with a strong focus on ocular disease management, glaucoma treatment, and advanced clinical equipment. In addition, Graham holds positions as a Senior Fellow at the University of Melbourne Department of Optometry and Vision Science. He sits on the Optometry Board of Australia's Scheduled Medicines Advisory Committee and Optometry Australia's Glaucoma Clinical Practice Guidelines group. Graham is a peer reviewer for *Clinical and Experimental Optometry* and has presented at both local and international meetings.



### Michael Yapp

Michael is an optometrist and Head of Clinical Operations and Teaching at the Centre for Eye Health where he has been an instrumental force since its inception in 2009. Throughout his career he has had a diverse range of clinical experience, working in private optometry and ophthalmology practices and undertaking locum work Australia-wide and overseas. Michael's interest in education started early in his career when he was staff optometrist at UNSW. Since then he has continued to educate generations of optometrists and has been invited to speak at numerous Australian optometry conferences as well as prominent international conferences in New Zealand. India and the USA.



### **Katherine Masselos**

Katherine is an ophthalmologist in Sydney with subspecialty interests in glaucoma and cataract surgery. She completed a fellowship in glaucoma surgery at Manchester Royal Eye Hospital in the United Kingdom and has presented at Australian and international ophthalmic meetings. She has published widely in peer-reviewed literature. During her fellowship she was an investigator in an international trial of microstents for the treatment of glaucoma. She is a member of the Glaucoma Australia Ophthalmology Committee.



### John Pearce

John is a rural optometrist with a special interest in glaucoma. He completed his PhD on the variability in visual fields and OCT in glaucoma at ANU in 2017. He was appointed an Adjunct Lecturer at the John Curtin School of Medical Research at ANU in 2017 and was appointed as a Lecturer at the University of Canberra School of Optometry in 2019. He has been in clinical practice in regional NSW for over 30 years as well as farming 1600 acres for the last 20 years. He also completed his Master of Optometry degree in 1996 and his Graduate Certificate in Ocular Therapeutics in 2010.
