


COVID-19 AND OPTOMETRY

Renewed call for optometrists to deliver vaccines

The Victorian Government is again calling on optometrists to join the outbreak response workforce as [Limited Scope COVID-19 Vaccinators](#). The rise of the Omicron variant and shortening of the recommended interval for vaccine booster eligibility has resulted in the need to increase the vaccine workforce pool.

Optometry professionals and students are eligible to become part of the workforce. You will be given training, support, supervision, and personal protective equipment (PPE). Short and longer-term positions are available across metropolitan Melbourne and regional Victoria. [Find out more](#).

Wondering how to deal with bad patient behaviour?

Have you encountered bad patient behaviour? If your business is required to ensure that patients are wearing a mask, chances are the answer is yes. If patients are aggressive or intimidating, your safety and the safety of your workers is top priority.

Patients' vaccination status

While optometrists are not required to check patients' vaccination status, we have received questions about if it's possible to refuse patients who are not vaccinated. In response, Ahpra recently advised that it expects all health practitioners to facilitate access to care regardless of vaccination status. This means people cannot be denied care if steps can be taken to keep the person, health practitioners and their staff safe.

Practices may be considering how best to do this while also facilitating access to care in the current COVID-19 environment. Ahpra and the National Boards have developed guidance to help support good practice, which reinforces existing codes and guidelines and other publicly available information. [Read more](#).
