### SA public eyecare wait-times round table makes headway

On the back of [OV/SA's campaign](#) to reduce wait-times for public eyecare in South Australia, we held a round table with key stakeholders to see what can be done. We want to thank those who attended including ophthalmologists, optometrists, orthoptists, university representatives and Aboriginal health representatives. We had such a positive response to the first meeting that we'll be hosting a second meeting in Adelaide in July to accommodate those that weren't able to

attend the first meeting. This will further inform and drive our efforts to achieve tangible solutions to the issues identified, in partnership with the South Australian eye health sector.

## Workforce Survey results announced

A big thanks to the 149 members who responded to our recent workforce survey. The main takeaway from the results is that many of you are having difficulty recruiting non-optometry practice staff.

It was encouraging to see 80 percent have not had more difficulty recruiting optometrists in the past six months. However, we're concerned that 58 per cent of you are having difficulty recruiting non-optometry practice staff. This is mostly affecting practice owners in inner Melbourne (40 percent) followed by outer Melbourne (28 per cent). A small number of practice owners in regional Victoria and metropolitan and regional SA are also having difficulty.

The main reasons cited was an insufficient pool of suitable workers. It was also mentioned that the pandemic had changed how people feel about public-facing work.

In response to the survey results we have identified several actions, which include talking with Optical Dispensers Australia on potential areas for collaboration.

## Austroads to update 'fitness to drive'

The national driver medical standards Assessing Fitness to Drive have been updated. The new medical standards, which optometrists must abide by, will support health professionals to assess patients' ability to drive safely. The 2022 edition will be effective and accessible from 22 June. OV/SA will provide comprehensive updates on what the changes mean for you and your practice. In the meantime a summary of changes is available on the [Austroads website](#).



An additional change not highlighted in the summary, is the wording around the use of Humphrey visual fields analyser or equivalent. The national guidelines now note specifically that a Medmont binocular VF printed off in level map mode is accepted as equivalent to a Humphrey. This reflects changes secured in 2019 following advocacy by OV/SA with Victorian driving licensing authority, VicRoads.

We're pleased to see this is now enshrined in the national requirements. We're currently advocating at the state level regarding mooted changes to requirements related to patients undergoing orthokeratology, and will advise members of any state-specific requirements if and when they're finalised.

## COVID-19

## Reminder: mask and vaccination requirements

### South Australia

The South Australian Public Health Act 2011 has been updated with many existing requirements remaining the same. [Masks are still mandatory](#) in healthcare settings including optometry practices for patients 12 and over, and all optometry staff, unless a valid exemption applies.

COVID-19 vaccination requirements for healthcare workers also remain. This means everyone working in optometry settings must be vaccinated against COVID-19 with a third dose (booster).

## **Victoria**

Face [masks are still mandatory](#) for everyone aged 8 and above while visiting a hospital, care facility or public space in a healthcare setting, including allied health settings. This means all optometrists, front of house staff and patients must continue to wear a face mask in the practice.

The Victorian Government is continuing to do compliance visits in a range of businesses, including optometry practices. Compliance officers will usually email first and remind practices about the ongoing requirement for business (including optometry practices) to have a COVIDSafe Plan.

## **Small Business Ventilation Scheme**

The Victorian Government ventilation scheme - part of its [stimulus package](#) to support businesses - has opened. This includes offers such as \$500 to support businesses to buy air purifiers or ventilators and up to \$5,000 to improve ventilation through building works.


