



ECOV'S DIAGNOSTIC DILEMMAS

There was a very positive response to the Early Career Optometrists Victoria (ECOV) seminar on diagnostic dilemmas in March, with around 60 members taking time out of their busy schedules to attend.

Guest speaker Anne Weymouth delivered an interesting and challenging presentation on diagnosing the less obvious causes of vision loss such as neurodegenerations, retinal and optic nerve dystrophies and autoimmune, inflammatory and paraneoplastic related disease.

Anne's presentation included discussion around non-glaucomatous visual field loss, acquired colour vision defects and electrodiagnostic and imaging tools that are useful in diagnosing neural aetiologies to vision loss.

A team-based learning session facilitated by members of the ECOV committee followed Anne's presentation, and provided participants with the opportunity to work together in small groups on case-based discussion.

Participants received 6 CPD points (with assessment).

FLEXIBLE WORKPLACES WEBCAST


POPULAR WITH VICTORIAN MEMBERS

OPTOMETRISTS SUPPORT FREE

GLAUCOMA SCREENING CLINIC AT WGC

Optometry Victoria worked closely with Glaucoma Australia to support the free glaucoma screening clinic which was held as part of the World Glaucoma Congress in Melbourne on 27 March.

Seventeen members responded to the call from Optometry Victoria to participate in the screening clinic. Utilising the latest mobile detection technologies 36 patients were screened by measuring intraocular pressures, by taking fundus photographs and performing visual fields tests.

The screening clinic was followed by Glaucoma Australia's patient symposium, which aimed to inform and educate glaucoma patients and their families with presentations from leading glaucoma specialists.

KEEPSIGHT CAMPAIGN TO

REMIND PATIENTS ABOUT EYE EXAMINATIONS

KeepSight is a new national program designed to ensure that the 1.3 million Australians living with diabetes undergo regular eye examinations.

The program is an initiative of Diabetes Australia and Vision 2020 Australia, and is supported by Optometry Australia, Specsavers, the Centre for Eye Research

Australia and a range of other eye health organisations.

The program aims to prevent diabetesrelated vision loss by encouraging people with diabetes to make an appointment with their local eye care professional for a diabetes eye check.

Optometrists are encouraged to register with the KeepSight webportal. This enables optometrists, with the consent of the patient, to record a patient's diabetes-related eye examination. The KeepSight portal will then automatically remind patients registered with the National Diabetes Services Scheme when they are next due for a comprehensive eye health examination.

For optometrists to register with the KeepSight webportal takes about 60 seconds. Optometrists will need their AHPRA registration number handy, to complete the registration process. For more information visit keepsight.org.au

ACADEMIC AND CLINICAL EXCELLENCE: ISAAC CURKPATRICK



Optometry Victoria is delighted to announce that Isaac Curkpatrick is the winner of the 2019 Academic Award: University of Melbourne.

The Academic Award recognises the final year student who epitomises the highest commitment to patient care, including outstanding clinical aptitude, commitment to evidence-based practice and professionalism.

Isaac completed his optometry degree with the University of Melbourne in late 2018.

"I really enjoyed my time at the University of Melbourne. The highlight of the course was definitely my externship placement in Oklahoma in the United States," Isaac said.

"The scope of practice for optometrists in Oklahoma is incredible, I had the opportunity to perform anterior eye YAG laser procedures as well as minor eyelid surgical techniques. My training here in Australia was easily translated to skills needed for this wider scope of practice," he said.

Since graduating Isaac has taken a role with OPSM in the Adelaide CBD in South Australia.

"I really enjoy making my own clinical decisions now that I am not a student, and I'm excited that there is still so much to learn," Isaac said.

We asked Isaac how he feels about winning the award.

"I feel very honoured to be recognised for all the hard work I put in over the years. I was caught by surprise when I found out I was the recipient, as there are so many deserving colleagues that graduated with me," Isaac said.

POSTGRADUATE TRAVEL GRANT WINNER 2019



The winner of the 2019 Optometry Victoria international postgraduate travel grant is Kai Lyn Goh.

The \$1,000 grant will enable Kai Lyn to travel to the Association for Research in Vision and Ophthalmology meeting in Vancouver, Canada from 28 April to 2 May, to deliver a poster presentation.

Kai Lyn's research has analysed vision screening data from a Victorian

children's vision screening program Glasses for Kids that ran from 2016-2018. The program screened 20,634 school students in Grade Prep, 1, 2 and 3.

For this presentation, Kai Lyn analysed a subsection of these students screened between February and March 2018 by final year Doctor of Optometry students from the University of Melbourne. She found that referral rates from the program were two to three times higher than other comparable programs, with 61 per cent of children recommended for further review.

"We believe that the high rate of referral may reflect the strictness of the referral criteria used, including referring all children who were unable to complete a test. Referral rates were highest in the youngest children, and this is likely the result of when the screening was conducted for these particular students, very early on in the school year," Kai Lyn said.

"Using different tests that young children are more likely to complete, as well

as relaxing the referral criteria, might improve the performance of any future iterations of the program," she said.

We asked Kai Lyn what winning the award meant to her.

"Winning this award will give me the opportunity to interact with other researchers in this field. I am keen to hear about the latest developments in this space, and hope to be able to bring these lessons back to our own school vision screenings," Kai Lyn said.

Kai Lyn has practised optometry in regional Victoria and metropolitan Melbourne. She is currently employed in an ophthalmology clinic undertaking pre and post-operative assessment of refractive surgery patients. She is also a pre-clinical teaching instructor at the University of Melbourne. Kai Lyn is pursuing a Masters by research in public health optometry and expects to complete her degree in 2020.

MEMBER PROFILE

SUZY AND RICHARD I ENNE:

A SHARED PASSION FOR OPTOMETRY



Suzy and Richard Lenne are group practice optometrists in a busy independent practice in Echuca. The business has eight optometrists with an outreach location in Kyabram and visiting arrangements with local nursing homes and the Nathalia hospital. Suzy and Richard have worked together since they graduated, and have also been married for twentythree years.

"Suzy and I were both from country Victoria, but met in the first year of our optometry degree at the University of Melbourne. We graduated in 1992, but I stayed on and completed a Masters of Optometry, graduating in 1996," Richard said.

Suzy had been keen to get back to country however. "After four years of student-living in the city I took a job in Swan Hill when I graduated," Suzy said. "When Rich finished his Masters he joined me there, and we worked together for two and a half years."

Suzy and Richard relocated to Townsville for two years, before moving back to Victoria and settling in Echuca where they've lived and worked for the last 19 years.

We asked them what they most enjoy about their work.

SUZY SAID. "I'VE DEVELOPED AN INTEREST IN CHILDREN'S VISION AND BEHAVIOURAL OPTOMETRY. I'VE STARTED TAKING A MORE HOLISTIC VIEW OF VISION AND BRAIN DEVELOPMENT, AND SEEING KIDS IS REWARDING. I LIKE BEING ABLE TO FOLLOW CHILDREN AND OTHER FAMILY MEMBERS OVER THE YEARS."

"I'm also a bit of a perfectionist," she said. "I still enjoy refracting and taking the time to explain things and answer patients' questions."

Richard has developed an interest in therapeutics, and completed his therapeutics qualification in 2006.

"I enjoy dealing with acute eye symptoms," Richard said. "I was the first optometrist in our practice with therapeutics and initially saw all the 'red eyes'. As more and more of our team are therapeutically endorsed the cases are spread out, however I'm still eager to see a patient who has acute ocular symptoms," he said.

"The advent of good imaging equipment has allowed me to collect a lot of interesting cases," Richard said. "I've been honoured to have the opportunity to speak at optometry conferences, including previous SRCs and the new O=MEGA19 in July this year. I was also part of a Collaborative Care Panel at the World Glaucoma Congress in Melbourne in March. I've really enjoyed sharing these cases with other optometrists, students and on a few occasions medical practitioners as well," he said.

"I AM PASSIONATE ABOUT RAISING THE PROFILE OF EYE CARE IN THE COMMUNITY AND ESPECIALLY KEEN TO INCREASE AWARENESS OF GLAUCOMA. SO I TAKE EVERY INVITATION TO SPEAK TO COMMUNITY GROUPS ABOUT OCULAR HEALTH," RICHARD SAID.

We also asked Suzv and Richard what they find most challenging about their

Suzy noted that working part-time can bring its own challenges. "It's sometimes difficult to stay abreast of changes in frame and lens technology, and it can take me longer to become proficient in using new equipment simply because I am not there doing it every day," she said.

"As a part-timer you can sometimes feel outside of the day-to-day happenings of the practice and it can be more difficult to follow patients. Having said that, I love working part-time and am lucky enough to be able to do so," Suzy said.

Richard highlighted that the challenges for him are associated with the nonclinical aspects of running a business.

"I don't have a natural business brain, so I attend ProVision events to fill in this weakness." he said.

"Being a group practice the partners have taken different responsibilities and mine has been to liaise with our IT support. With so many staff and optometrists the IT problems can be quite a handful," Richard said.

We also asked Suzy and Richard what inspired them to become optometrists.

Suzy noted that while she didn't have eye problems as a child her mother did. "My Mum had astigmatism and myopia and she wore glasses and contact lenses. In year 12 I became aware of optometry as a profession. I had no idea how much more than glasses and contact lenses optometry would be," she said.

Suzy added, "These days the positive feelings I get from building relationships with patients, as well as continuing education in my areas of interest, are what keeps me motivated. Use of OCT and other digital imaging has helped me maintain my confidence in managing patients and I love the extra information we can give patients about their eyes. I have started vision training in recent times and like anything new, it is making me think more deeply about what I am doing and why I am doing it."

Richard always wanted a science education and was happy to work in health care. "I feel fortunate that my job has plenty of variety and solving individual patient's eye health questions is rewarding," he said.

Suzy added, "We talk about work at home - I think we both find it good to debrief sometimes and we help each other out with tricky cases. It's great to discuss work and know that your partner understands exactly what you're talking about. We don't really have a problem with it, although sometimes if there's too much optometry talk our kids roll their eyes

OPTOMETRY **AUSTRALIA'S PRIORITY** RECOMMENDATIONS FOR THE 2019 FEDERAL ELECTION.

Priority one:

Ensure the relevant recommendations of the Medicare Benefits Schedule (MBS) Review are implemented, including the reinstatement of two-yearly rebates for initial comprehensive examinations for middle-aged Australians as a high priority.

Priority two:

Reassess scheduled fees for MBS optometry items so primary eye care services are sustainable and accessible. The lengthy freeze on indexation combined with the five per cent reduction to all optometry rebates in 2015, means that patient rebates for optometry items on the MBS are five per cent less today than in 2012 - yet the cost of providing quality primary eye care has continued to rise.

Priority three:

Increase awareness of the importance of comprehensive eye examinations for all in early childhood.

Priority four:

Support ongoing advancement in primary eye care through investment in applied research directed at shaping new models of care that maximise the skills of optometrists and further integrate optometry across the health system.
