

EDITORIAL

COVID-19 has impacted optometry and optometrists in ways not seen in our lifetimes. The ability to see and care for patients, to run businesses and to collaborate with peers, colleagues and other health professionals has radically changed, and will continue to evolve as we wade into unchartered waters.

This is a stressful time for most people, and everyone is affected. We hope that you and your families, as well as your friends and colleagues are safe and well and are coping in this strange and uncertain environment.

Optometry Victoria South Australia (OV/SA), in close collaboration with our national organisation Optometry Australia (OA) and the other State Divisions, have been working hard since the onset of the pandemic to ensure that members are kept up to date on the latest clinical information, business support and HR and employment advice.

OA has led the way for the entire optometric sector throughout the crisis phase of this response. OA's calm, measured and ethical leadership has been very much appreciated by us.

The COVID-19 pandemic presents an ever-changing environment – it can feel like the sand shifts under our feet every day and we're sure many members feel that too. Advice from the federal government, from state governments, from health experts and from our national association will continue to change fairly rapidly, so we must stand ready to pivot and adapt, and ultimately evolve.

Despite these challenges we commit to keeping members informed with the very latest information and advice as it's updated. We also will continue to keep members connected through our events and online forums, and supported through our services and expertise.

Membership renewal 2020-21

In recognition of the significant financial impact of the COVID-19 pandemic on optometrists and optometry practices, we have announced that membership fees across all member categories will be halved for 2020-21.

This is equivalent to six months of free membership for every member, and members will also have the option to delay payment until later in the year if they wish.

This arrangement is in place for all members across Australia irrespective of where they practice and is the result of wonderful collaboration between OA and all State Divisions.

In no small part the deal was able to be struck through a decision taken by the OA Board to fund half of the fee reductions for all states. That OA can do this for all State Divisions says much about their leadership, financial prudence, and steadfast desire to preserve the collective strength of the association.

Optometry Victoria and Optometry South Australia as separate businesses were strong and financially well run - together OV/SA is demonstrably stronger. We have determined that the very significant shortfall in membership revenue we will experience in 2020-21 as a result of fee reductions can be funded through reserves without the need to take on debt or reduce member services.

We must stress, though, that reductions offered for 2020-21 will be a one-time only arrangement. OV/SA will not be in a position to reduce fees again in 2021-22, and it is anticipated that as we emerge from the pandemic membership levels will return to (approximately) 2019-20 levels. If members have any questions about that please feel free to contact us.

To take advantage of the 2020-21 fee reductions, members MUST renew by 30 June 2020.

To renew simply go to optometry.org. au and log-in to the member portal. Indicate your intended membership category, which will be based on the number of hours you are most likely to be working across the 2020-21 financial year following the removal of COVID-19 restrictions.

Once you have done this you will have the choice of the following options:

- pay the discounted fees in full by 30 June 2020, OR
- pay the discounted fees in full by 31 December 2020, OR
- pay 12, monthly installments at the discounted rate from 1 July, OR
- pay six, monthly installments at the discounted rate from 1 January 2021.

If you decide to pay later we will contact you in around October or November – rest assured you will have full access to all OV/SA and OA services and benefits if you decide to pay later in the year. However you must indicate that this is what you intend to do, by 30 June 2020.

Advocacy for the profession

Advocacy on behalf of members and the profession has never been more important than throughout the changing environment of COVID-19. Together with our national association we have advocated at state and federal levels in an effort to ensure that optometry can emerge from this pandemic well placed to continue to care for the health and wellbeing of our patients.

In the early stages of social distancing restrictions there was a very real risk of a complete shut-down of optometry practices. OA advocated to the Federal Government for optometry practices to be able to remain open to provide essential and emergency eye care for patients. The Federal Department of Health heard and accepted this call. and their subsequent recommendation to optometrists and patients reflected this position.

In parallel OV/SA wrote to the lead ophthalmologists in each of the public hospitals in South Australia and Victoria, the South Australian and Victorian chapters of RANZCO and the South Australian Department of Health and Victorian Department of Health and Human Services.

We reiterated the benefits of optometry practices remaining open for emergency and essential eye care, in particular the benefit to patients of being able to remain in their local community for eye care where possible, the potential to reduce the burden on the public health system and, to freeup ophthalmology to focus on critical surgical or COVID-19 related care.

The majority of responses to these letters were positive, with a number of ophthalmologists expressing interest in talking further about opportunities to collaborate, once the crisis phase of the pandemic is over.

OA and OV/SA both advocated for access for optometrists to personal protective equipment (PPE). However the very limited supplies of PPE in the National Stockpile were severely rationed to frontline hospital staff and

those treating people diagnosed with COVID-19, and stocks unfortunately remain limited to these groups.

OA has continued to strongly advocate for a Medicare item number for telehealth for optometry. Medicare has been overwhelmed by requests from a wide range of health professions for telehealth item numbers and has been steadily working their way through the list. OA continues to advocate for this and will advise members as soon as any updates from Medicare are received.

OV/SA has also advocated for optometry access to the Victorian Business Support Fund which is providing grants of up to \$10,000 to business significantly affected by the pandemic. Phase one of distribution of grant funds saw optometry applications rejected on the basis of their ABN registration number.

OV/SA immediately spoke with and wrote to Small Business Victoria to outline the enormous impact of the pandemic on optometry practices, and were heartened by the advice that phase two of the program would be open to allied health professions including optometry. We continue to closely watch this space and urge any members experiencing difficulties with this program to contact us with details.

OV/SA in partnership with OA, will continue to advocate for optometry throughout the COVID-19 pandemic and beyond, in order to ensure a viable and ongoing future for the profession.

CPD and member events

Our plans to deliver in 2020-21 a twelve-month, comprehensive calendar of CPD events for members has evolved over the last couple of months in line with the limitations imposed by social distancing requirements.

Throughout late May and June we will be delivering online CPD and career events for members with the Careers Expo 2020 for final year students from Deakin University, Flinders University and the University of Melbourne to be held in late May; the next ECOV/SA seminar at the beginning of June and, the last of the

rural and regional seminars with guest speaker Richard Lenne in mid-June.

We are currently anticipating the lifting of domestic travel restrictions sometime in the coming months, and we are planning a host of face-to-face events for members across the two states, including Blue Sky Congress 2020 in Adelaide in November.

You can read more about a number of these upcoming events in this edition of Scope, and we will continue to update members as events are confirmed.

Once again we thank you for your ongoing support of the association, for your resilience in the face of significant adversity and, for your dedication and care for your patients. It has been said often, that these are unprecedented times. However we will endure as a profession, and we will grow stronger, together.

ALEXIS 'CEECEE' ZHANG:

POSTGRADUATE TRAVEL GRANT WINNER



The winner of OV/SA's postgraduate travel grant for 2020 is Alexis 'Ceecee' Zhang. Ceecee's research aims to understand the attitudes and practice behaviours of optometrists towards recommending nutrition interventions, in the form of dietary changes or supplements, to patients with ocular disease. Ceecee surveyed over 250 optometrists from Australia and New Zealand for her study.

"Four out of five optometrists participating in the research indicated recommending omega-3 fatty acids, via dietary modification or oral supplementation, to their patients for improving their ocular health. These findings suggest that optometrists are actively engaged in providing dietary and nutritional guidance for ocular heath, to patients," Ceecee said.

"We also identified, from our survey, areas where future guidance could support optometrists in making evidence-based nutrition recommendations in eye care practice," she said.

Ceecee had originally planned to use the travel grant to present her research findings at the Scientific Educators' Meeting in Optometry (SEMO), which was to be held in Auckland, New Zealand in April. However, the COVID-19 pandemic resulted in the cancellation of the conference. Ceecee now intends to use the prize money to travel to the Ocular Surface laboratory at the University of Auckland once travel restrictions have been lifted.

"The Ocular Surface laboratory has a corneal aesthesiometer, one of only a few comparable instruments that exist in the world. It was built by an Auckland-based ophthalmologist and provides a non-invasive method to measure corneal sensitivity," Ceecee said.

"In terms of promoting my research results, our survey results are now published in a scientific journal (PMID: 32331489). I also plan on sharing these findings with the wider optometry community via continuing education channels and, if possible, at professional conferences later in the year," she said.

"I'm hoping that these findings will help inform future education programs about eye health and nutrition, particularly in clinical education articles and conferences. These are the main sources of information optometrists indicated using to guide their clinical decision making," Ceecee said.

"I'd like thank OV/SA for awarding me this grant and the opportunity to further my research," she said.

ZOE ZHANG:

ACADEMIC AWARD WINNER UNIVERSITY OF MELBOURNE



The OV/SA Academic Award recognises a graduating student who epitomises the highest commitment to patient care, including outstanding clinical aptitude, commitment to evidence-based practice and professionalism. The student receives \$1,500 which they can choose to spend however they wish.

OV/SA is proud to announce that this year's winner of the Academic Award (University of Melbourne), is Zoe Zhang. Zoe completed her optometry degree at the University of Melbourne in 2019.

We asked Zoe how she found the optometry degree at the University of Melbourne.

"The optometry degree at the University of Melbourne provided us with a solid foundation of theoretical knowledge integrated with an excellent range of placements. The teaching staff were very supportive and encouraged us to become skilful, empathetic and compassionate clinicians." Zoe said.

"I really enjoyed the placements during the final year of the course. My overseas externship was in New Jersey where I consulted under the guidance of both optometrists and ophthalmologists. This increased my exposure to different ocular pathologies and consolidated my skills in detection, treatment and ongoing

management of significant eye conditions," she said.

Since graduating Zoe has taken on a role with OPSM in Morwell and Traralgon. We asked Zoe how she's found the transition to practice.

"Transition into practice has been a very steep learning curve. Working in East Gippsland has been both challenging and rewarding. It has ranged from detecting a retinal detachment during my third week, to removing three corneal rust rings in a day at the start of social restrictions. This really highlighted the need for wearing eye protection whilst working from home as well!" Zoe said.

"Winning this award is a great surprise. It's a really nice recognition of all the hard work from the past four years. I graduated with such an excellent cohort of peers so it feels surreal to have been selected. I am certainly very honoured and thankful for the support from the University of Melbourne and OV/SA," she said.

Malcolm's acceptance speech was thoroughly entertaining, harking back to the first (and only other) time he won the trophy.



MEMBER PROFILE

SAO TYLER: HERE AND WILLING TO HELP



Sao Tyler graduated from her optometry degree at the University of Melbourne in 2009. After graduating she started work with Graham Hill Eyecare in Shepparton, and has been there for over ten years. During this time Sao has also taken on locum work in various settings all over Australia. She has a particular clinical interest in myopia control and contact lenses.

We asked Sao to tell us a little more about the practice and how she found making the move from the city to the country.

"Graham Hill Eyecare was established in Shepparton over 50 years ago. It's a single-clinic practice of five optometrists and eight support staff. We do everything here - disease management, Ortho-K, myopia control, low vision, subsidised eyecare scheme for low income people and contacts," Sao said.

"Our relationship with the local GP's, ophthalmologists and other health care professionals is strong, so people trust us with their eye health. I am so grateful and proud to be a part of a team that is so dedicated to eye care and community health," she said.

"Before moving to Shepparton I'd lived in the same family home all my life. But the move from city to country was unexpectedly seamless. I got involved with the local young professionals' group soon after settling, and Shepparton has a strong social scene when it comes to sports and fitness. I've found that regional living suits me well," Sao said.

We asked Sao about the strategies that have been put in place in the practice in response to the COVID-19 pandemic.

"Due to social distancing measures we have had to cut back to a skeleton staff, as the waiting room becomes quite full when all five optometrists are working. Patients are now asked to use hand sanitiser on entering the building before sitting in the waiting room alone, and to wash their hands at the sink in the optometrist's office with soap and running water. Our frames are also all hand washed with detergent after each patient," she said.

"Before lockdown we were booked three weeks in advance, so we're calling each patient and triaging their need to been seen during this time. Routine recalls have been put off for now, but we've placed notices on our social media and in the local newspaper that we're still available if they think they need us. They just need to call first," Sao said.

"We've also introduced an after-hours service for the weekends and after 5pm every day where we'd usually be closed. Anything to alleviate the stress on the local hospital and our patients in general," she said.

"Personally I'm doing more comanaging of patients with their ophthalmologist via telehealth. We usually have two or three ophthalmologists visiting Shepparton on a regular basis, but they've now either ceased their visits or severely cut back." Sao said.

We asked Sao how patients have responded to these strategies.

"It's been very rewarding seeing the relief in people's faces when they hear that not only are we open, but we are here and willing to help. Everyone is obliging with the hand-washing protocols and social distancing overall. You do get some people miffed about the amount of sanitising or washing of hands, however it's more for the reason that we're living in strange times, and their concern is that this is now the new normal," she said.

"We anticipate that as the restrictions lift we will slowly run the practice back to capacity. It is all unknown and everchanging, but at least our patients have some certainty that we are still open," Sao said.

We asked Sao what she enjoys most about working as an optometrist, and what she finds most challenging.

"I love the variety of optometry! The science of the job might sometimes be straight forward, but the needs of each patient are different. I might see lots of kids one day, maybe a few AMD patients, or a new keratoconic contact lens fit. Patients with low vision are another example of how I need to tailor as often there's no 'standard' treatment. I love that I can help these patients locally and they don't have to travel hours to Melbourne for care," she said.

"That variety also applies to locum work. It's so interesting seeing how other practices work, what they offer their patients and what optometry is like in each state. Those experiences definitely helped me to become a more well-rounded and knowledgeable practitioner," Sao said.

"The thing I find challenging is that I do wish that the Medicare rebate better reflected the work we do, especially in a regional area where there are less resources," she said.

"But I've been seeing some of my patients for over a decade. I've seen some grow up from toddlers to young adults ready for their driver's license. All my regulars were wishing me well when I was pregnant recently with my first child, and they are very much involved and interested in my life as I am in theirs," Sao said.

We asked Sao what inspired her to become an optometrist, and what keeps her going now?

"Growing up I was very science-minded, and I still am. I also had a calling to help others in the medical sense. Optometry felt like a good fit for me, and I was very impressed with the course at the University of Melbourne," she said.

"I knew I wanted to practice in a regional setting after doing country placements in my final year because of the experience that is unique to working in the country. I actually never intended to stay in Shepparton past two years, but ten years later I can't fathom going back to Melbourne," Sao said.

"Working at Graham Hill Eyecare continues to keep me driven as a practitioner. I've been encouraged right from the beginning to be at the forefront of optometry, for the benefit of our patients, and the longevity of my career," she said.

MEMBER PROFILE

MITCH HANCOCK:

IF IT'S WORTH DOING, DO IT THE BEST IT CAN BE.



Mitch Hancock grew up on the northern coast of New South Wales and graduated from the University of New South Wales (UNSW) in 1995. Following graduation he took a role with Laubman and Pank in South Australia working in various locations across the state. He became branch manager in Port Augusta in mid-1996 moving to the same role in Mount Gambier three years later. Mitch and his wife Tiffany took over an independent practice in Port Augusta in 2005.

Mitch completed the UNSW Therapeutics course in 1998, and a postgraduate Masters from UNSW in 2007. Due to the delay in getting therapeutics approved in SA he returned to study a few years later and once again completed a Therapeutics course, this time through Queensland University of Technology.

We asked Mitch about his practice in Port Augusta and his approach to running it.

"Tiffany and I have the ethos that 'if it's worth doing then do it the best it can be'. We aim to provide a standard of clinical expertise and equipment at our practice that far exceeds what is available to patients in the city," Mitch said.

"Patients in the country can be the poor cousins when it comes to access to health care and health outcomes, but we were determined that this would not be the case for eye care in our region. So technology and therapeutics have been areas of special interest for us," he said.

"We first installed OCT in 2009 so that patients could access anti-VEGF injections locally and we installed the third upgrade of Angio OCT a few years ago. We have most of the clinical tools an optometrist could ever want or need, much to our accountant's horror, but it does allow the broadest scope of practice and access to care for our patients," Mitch said.

We asked Mitch about the sort of strategies they have put in place in the practice in response to the COVID-19 pandemic.

"We were watching the developing crisis closely and the type of measures being implemented, and Tiffany would provide updates to the team each day," he said.

"Infections in SA were not yet really present when we made a host of changes so we could still manage the volume of emergency and essential ocular care patients that we see," Mitch said.

"To reduce the number of clients in the practice at any one time, we split the team into morning and afternoon shifts with closure in between for cleaning of the practice and to allow time for the morning team to exit before the afternoon team arrived. We extended the practice hours from 8am to 8pm with a 20 minute gap between all appointments to allow full disinfection between each patient," he said.

"We brought forward appointments for higher risk patients that had ocular care needs such as wet macula or glaucoma so that they were effectively managed before the increased restrictions. We also established hand sanitising stations for patients on entry, taping on floors for social distancing guidance and ensured that we had only hard surface chairs that were spaced appropriately," Mitch said.

"We modified the layout of the consulting rooms, and ensured we had slit-lamp shields and face masks for all staff. We converted spare consulting rooms into dedicated space for clients to be directed to on arrival, and we opened other exits so that patients arrive through the front door and exit through an alternate door," he said.

"We started conducting health screening and phone triage before making appointments for clients, which was followed by additional health screening and part-exam history conducted by the optometrist before the patient attended for their appointment," Mitch said.

"We implemented protocols for all staff in regards to travel and social events, much of this well in advance of the announcements coming from national cabinet. Our staff have been fantastic throughout all of this and very accepting of the changes," he said.

"Our team continue to work part of their hours from home and are involved

in team meetings via videoconference. During home work time staff do training (including the SA health COVID-19 infection control trainings), social media work, and make calls to our more vulnerable patients to check that they were feeling well not just physically, but socially and emotionally," Mitch said.

"We also started making texts and calls to our team at the end of each weekend to make sure that everyone was well and coping," he said.

We asked Mitch how patients had responded, and whether some strategies were more effective than others.

"Patients have generally been great with the changes. Initially some were a bit surprised and a bit blasé about it all. There was feeling that as a more remote country location, this was not something they had to worry about. But the level of seriousness with which we were taking patient safety helped to educate them and, as the weeks went on, more patients were relieved they could still get their eye health attended to," Mitch said.

"We believe it's important to continue to do things in this new way, even when some people no longer see it as necessary. We're assessing which of the strategies we've put in place have improved patient experience and care so we can retain those into the longer term," he said.

"The current crisis has forced many tough changes, but not all have been bad, and we'll be focussing on retaining those positive silver linings personally and professionally," Mitch said.

We asked Mitch what he enjoys most about working as an optometrist.

"It's the people, and the relationship that you build with them over time that I enjoy most. When I first started it was the fascination with the eye and vision, and I still do get a buzz out of that, as well as the technology and solving problems," he said.

"But finding a way to help people understand what is going on with their eyes and vision and how they can be involved in making the best out of their most dominant sense, is now the biggest driver for me," Mitch said.

WHAT OPTOMETRISTS NEED TO KNOW


