Kiran Sookroo stepped down as President with myself replacing him. Eden Kwok and Roxanne Medhora both stepped down with Eden remaining as an advisor to ECOWA and Roxanne as OWA President.

Our last event of the year was a joint CPD event with Early Career Pharmacy Working Group WA sponsored by Alcon. The talk was centred around glaucoma, with a short presentation by Megan Zabell, an optometrist from Alcon Professional Affairs ANZ. She introduced the improved Systane Hydration eye drops with sodium hyaluronate and HP-Guar for enhanced ocular protection and hydration.

Following this, senior UWA lecturer/pharmacist, Kenneth Lee and OWA Vice President/optometrist, David Hsu provided an informative talk on glaucoma types and available therapies. Kenneth elaborated



further on factors to consider when prescribing eye drops such as systemic and/or ocular contraindications, health literacy and medication regime. David provided case studies which highlighted the importance of compliance, close monitoring and education in improving patient outcomes. At the end, a Q and A session was held with questions relating to each other's scope of practice.

This talk booked out very quickly, partially due to the limited seating capacity enforced by COVID. As always however, the event was very successful in its execution, allowing for more interprofessional development and better understanding of one another's role in the health industry. Our aim is to hold another collaboration event with Pharmaceutical Society of Australia next year, with hopes to eventually invite other interested health professions into the mix.
